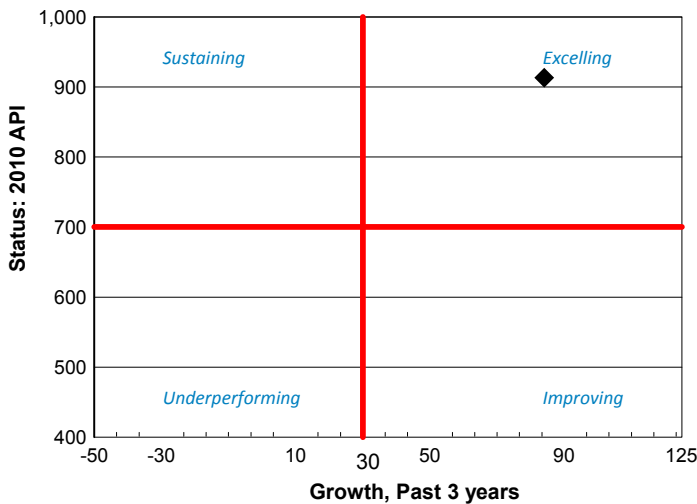

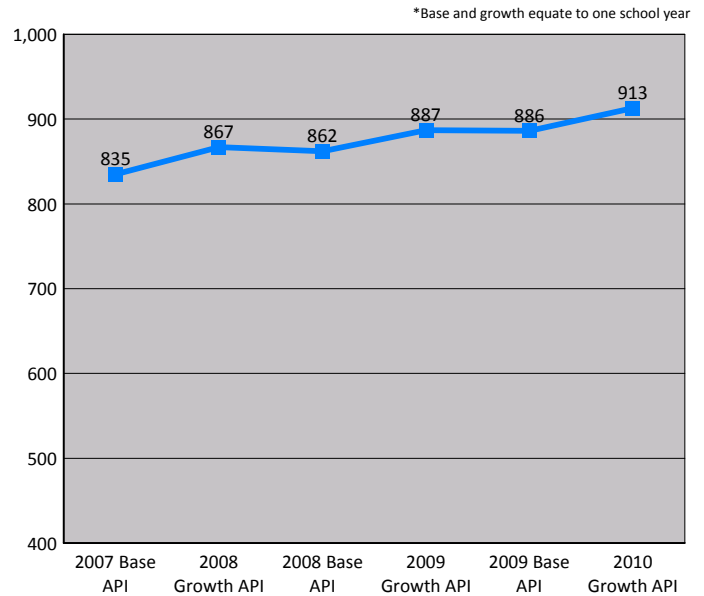

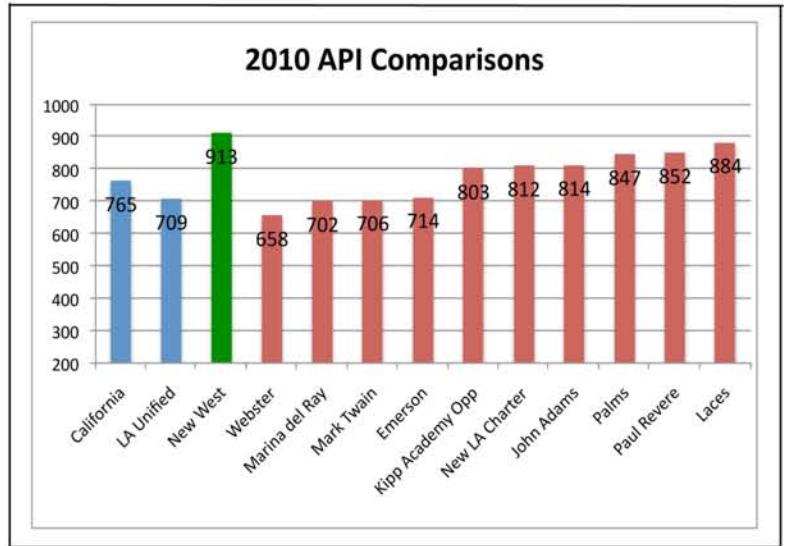

### Addendum: State Board of Education ("SBE") Regulations

On November 9, 2010, the SBE adopted regulations implementing its authority to take appropriate action, including, but not limited to, revocation of the school's charter when the SBE finds that there is a "substantial and sustained departure from measurably successful practices such that continued departure would jeopardize the educational development of the school's pupils." We expect these regulations to go into effect for the 2011-12 school year.

Criteria for revocation eligibility (only applied to non-ASAM schools 5 years and older):

- Statewide Rank of 1 over the past two years and 3-year cumulative growth under 50 points

<b>Similar Students Measure (SSM)</b>	Compares a school's API to its Annual School Performance Prediction (ASPP) over three years.
