In developing our 2021-2024 LCAP, New West presented the plan at a regularly-scheduled, open and public board meeting on May 11, 2021 to receive input and comments on the proposed plan from New West families and community stakeholders. Additionally, a condensed version of the plan, specifically focusing on expenditures related to increased and improved services for high need students, was created for parents and presented during the meeting. The LCAP was approved by the Board on June 15, 2021.

Throughout pandemic-related closures, teaching staff and school administrators were in frequent contact with New West families, addressing urgent needs (food, internet connectivity, technology) as well as planning for longer term needs identified during this stressful and uncertain period (student mental health and wellness, supplemental instruction to address learning loss). School site

staff and teachers communicate with families over the phone, email, and through our web-based student information system. Additionally, New West administered three large family surveys in the 2020-2021 school year to ensure families were provided a formalized opportunity to have input into decision-making around the distance learning format, reopening options and procedures, and other school climate related questions. Several focus groups were also conducted, which included parents, students and other community stakeholders, to ensure opportunities for input and feedback were provided in a number of formats.

For students, New West distributed surveys and teachers held classroom discussions during Advisory group time to gain perspective on the student experience, what they felt was working well, and what they needed to be successful. Feedback in Advisory group time was shared with school leadership and survey results helped inform where to direct resources.

#### A description of how the development of the plan was influenced by community input.

In our frequent communication with New West families through informal communication, formalized surveys, and several focus groups, we heard concerns about the safety of returning to in-person instruction. These concerns helped inform our spending on Personal Protective Equipment and led us to increase the number of hours and frequency our janitorial service spends cleaning and disinfecting shared spaces—classrooms, kitchens, bathrooms, meeting spaces, etc., in addition to increased costs for cleaning supplies for school site personnel.

Families also expressed concern (in direct conversation, and via our web-based student information system, formal surveys, and focus groups) for the mental health of their children during long periods of isolation, especially how this period has negatively impacted our SPED students' mental and emotional health, and their academics. While New West enjoyed the daily engagement of more than 98% of our students, SPED students are over-represented in the small remaining percentage of students who were mostly or entirely disengaged from distance learning. In response, New West has hired one FTE Educational Psychologist to provide mental and emotional support for our SPED students. The Educational Psychologist will provide mental health interventions for disengaged SPED students (and other high needs students) during any necessary distance learning, in addition to ensuring the safe and successful transition for SPED students back to in-person learning. These efforts will necessarily be individualized and tailored to the students' unique needs; as such the Educational Psychologist will work closely with SPED families and teachers to ensure the best approach for each student in making measurable progress toward individualized academic and social-emotional goals.

Based on the input received from students, they are eager to return to in-person learning where they can have opportunities for social interaction. Ensuring their physical safety influenced our decision to dramatically increase (by approx. 50%) janitorial services to reduce the incidence of illness. Ensuring their mental health and emotional wellbeing inspired our decision to hire the Educational Psychologist who, while primarily focusing on SPED students, will be available to all students for interventions and referrals.

Additionally, informal and formal feedback and input from teachers and staff largely reflected the concerns raised by parents and students (physical safety, mental health and emotional support).

## Introduction

A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
  - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

  - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.

IDEA, and ensuring other educational services can continue to be provided consistent with all Federal, State, and local requirements;

- Purchasing education technology (including hardware, software, and connectivity) for students who are served by the LEA that aids in regular and substantive educational interaction between students and their classroom instructors, including low-income students and children with disabilities, which may include assistive technology or adaptive equipment;
- Providing mental health services and supports, including through the implementation of evidence-based full-service community schools;
- Planning and implementing activities related to summer learning and supplemental after school programs, including providing classroom instruction or online learning during the summer months and addressing the needs of underserved students;
- Addressing learning loss among students, including underserved students, by:
  - Administering and using high-quality assessments that are valid and reliable, to accurately assess students' academic progress and assist educators in meeting students' academic needs, including through differentiated instruction,
  - Implementing evidence-based activities to meet the comprehensive needs of students,
  - Providing information and assistance to parents and families of how they can effectively support students, including in a distance learning environment, and
  - Tracking student attendance and improving student engagement in distance education;
