

## TMMP/STUDENT TRANSPORTATION, INFORMATION, OPTIONS & PARKING POLICY

In order to allow for the most efficient and orderly student drop-off, pick-up, and parking flow, you must select a method of transportation for your student as to not be in violation of the Home-School Agreement. You are required to use your selected mode of transportation for the entire school year.

## **Drop-off & Pick-up Times at School Sites:**

### Grades 6-7 (Pico)

- Arrival drop-off: 7:30 a.m. to 8:25 a.m.
- O Dismissal pick-up: 3:15 p.m. to 3:45 p.m.
- After-school Program pick up 4:00pm

#### **Grade 8 (Armacost)**

- Arrival drop-off: 7:30 a.m. to 8:25 a.m.
- O Dismissal pick-up: 3:15 p.m. to 3:45 p.m.

### **Grades 9-12 (Armacost)**

- o Arrival drop-off: 7:00 a.m. to 7:25 a.m.
- O Dismissal pick-up: 2:25 p.m. to 3:45 p.m.

### The following transportation options are available:

- Walk/bike to school (mandatory if they live within a mile of the school).
- Take public transportation / Expo line (TAP letters will be provided).
- Carpool with three or more students (must be approved by New West). Carpool at Armacost must have a minimum of three riders.
- Ride a shuttle bus to school (multiple locations available across West LA).

## Walk/Bike/Public Transportation

- Students that live within a mile radius of the school are expected to walk or bike to school unless safety or special circumstances prevent it.
- Public Transportation is available. Expo line is available and a short walk of .7 miles to either site. For the Armacost site the station is EXPO/BUNDY. For the Pico site the station is EXPO/SEPULVEDA. TAP letters & Expo Line information is available.
- Bicycle parking spaces will be provided on-site. Students should provide their own bike locks and safety gear.

## Carpool - ARMACOST

- Carpools must be approved.
- All carpool vehicles must use a NWC 2019-20 windshield decal provided by New West to access the school during arrival and dismissal times.
- Carpool is limited and cannot be guaranteed. Decals will be given out on a first come, first served basis with preference to carpools with more students.
- Middle School students can travel to school early if they have siblings in High School, and their siblings may stay after-school and wait for the middle school dismissal period to travel home together.
- Carpool vehicles must carry a minimum of three (3) students each, the entire school year, in order to be approved by New West Charter School.
- Armacost Vehicles may only ENTER the school parking via Missouri ave and can only enter by turning right. Vehicles may only EXIT via Armacost Avenue turning right only.
- Pico- Vehicles may only ENTER the school parking via Tennessee Ave and can only enter by turning right. Vehicles may only EXIT via Bundy turning right only.



# TMMP/STUDENT TRANSPORTATION, INFORMATION, OPTIONS & PARKING POLICY

- All carpool vehicles to and from the school must load and unload on the school parking lot surface.
- During the school year, one or more parking monitors in distinctive attire will be located
  at each driveway entrance during drop-off and pick-up hours and at all special events.
  Drivers must follow all directions from parking monitors to assure that school-related
  vehicles do not queue on adjacent streets, block any public right-of-way, and/or public
  driveways.
- If you are looking for a carpool, please use <u>Carpool Connect</u> (C) to share and discover families who are also looking.

#### **Shuttle Bus**

• There is a \$500/year or \$300/semester cost per student for all shuttle bus routes. Families with more than one child using the shuttle bus service are eligible for a discount of \$50 per semester for the second and subsequent child. Payment is due at the time of shuttle sign up. Shuttle bus space is limited.

## Visiting/Parking Rules

- Due to numerous safety and legal reasons we cannot allow ride-sharing services like Uber, Lyft, or HopSkipDrive to pick-up or drop-off students at New West. While we understand the convenience and ease of use these services provide, students caught using the service will be considered in violation of New West Charter School's TMMP policy.
- The school parking lots are not available for parking during school hours. The parking lots are only available during select after school events and times.
- Street and metered parking is available at both sites. Please be aware of street parking restrictions. New West is not responsible for any vehicle fines or damages incurred while at school.

• <u>Students are prohibited from driving to school</u> and from parking at the New West Charter School site or on residential streets.

## For the Armacost Campus:

Failure to comply with the TMMP/ TRANSPORTATION POLICY, including violations at school or the shuttle locations could put your child at risk of losing enrollment at New West. New West has strict consequences for all families. Please see below a reminder of the NWC Governance Council approved TMMP policy consequences for non-compliance:

TWO TMMP Violations	FORMAL WRITTEN WARNING to Parent/Guardians including re-issue of NWC Home-School Agreement

SIX or More TMMP Violations	NWC GOVERNING BOARD HEARING
